This is an application filed by the Financial Creditors seeking replacement of the IRP appointed vide order dated 29.05.2024 by this Adjudicating Authority. Heard Ld. Counsel for the Applicant. Vide order dated 29.05.2024 while admitting the CIRP against the Corporate Debtor, this Adjudicating Authority had appointed Mr. Akash Shinghal, as IRP. The name of Mr. Akash Shinghal, was proposed by the Financial Creditors themselves. Ld. Counsel for the Applicant submitted that they have received a letter from the said IRP Mr. Akash Shinghal that he is not currently having the valid AFA and therefore, cannot act

as IRP. In view of this, a need has arisen for new IRP to be appointed. Now the Financial Creditors have suggested the name of Mr. Chetan Gupta bearing registration No. IBBI/IPA-002/IP-N01168/2021-2022/13950 as the IRP. The consent letter and the valid AFA of the Mr. Chetan Gupta has been filed. Since the IRP appointed by this Adjudicating Authority was not having valid AFA on the date of passing such order and in view of the request submitted by the Applicants/Financial Creditors, we hereby appointed Mr. Chetan Gupta, as IRP whose details are mentioned above to act as IRP in the matter. The appointment of IRP be read with the order dated 29.05.2024 and the newly appointed IRP is directed to take all responsibilities and activities as mentioned in the said order. With these observations, IA **disposed** of.
